PORT MANDURAH RESIDENTS' ASSOCIATION INC. President's Report

Presented at the AGM on 10 September 2020 by Jim Booker

In summary, the OBJECTS of your Port Mandurah Residents Association are:

- 1. To represent the ratepayers to oversee the expenditure of the Canal Frontage Rate (SAR), maintaining and where possible improving the quality of the development and preserve the resident's lifestyle. Via quarterly PMCWAG meetings.
- 2. To support and encourage the maintenance of standards throughout the precinct.
- 3. To liaise and foster good working relations with government departments and other relevant bodies.
- 4. To foster good working relations with media and inform the public.
- 5. To publish information sheets and newsletters, benefitting members and non-members.
- 6. To encourage and foster social interaction between members.

To represent the ratepayers to oversee the expenditure of the Canal Frontage Rate (SAR), maintaining and where possible improving the quality of the development and preserve the resident's lifestyle.

Reading through previous President's Reports it is obvious that both PMRA and the City of Mandurah (CoM) share a common interest in maintaining safe, navigable waterways.

The CoM has the responsibility for dredging, to maintain these safe, navigable waterways and also preserve the integrity of other canal structures. Your Canal Frontage Rate (SAR) contributes to this maintenance.

Again in 2019/20 as in many past years, their efforts seem to have fallen short of the standards expected by your PMRA committee. Consequent to insufficient dredging, several vessels have run aground, and a number of canal residents have given up waiting for adequate channels to be maintained and have sold their boats. The shallow waterway creates a dangerous situation especially during the summer months affecting the wider boating community as well as residents. Repairs to Cambria Island Retreat bridge abutment walls are, after a temporary fix some years ago, still pending a final decision of how to proceed. These points reinforce the need to maintain a close relationship with the Marina and Waterways, CoM and our local representatives.

To support and encourage the maintenance of standards throughout the precinct.

John and Jill Randall continue as a shining example with their daily litter pickup around Port Mandurah. Their efforts are recognised by the CoM and your PMRA receives financial reward.

Also, a special thank you to the many volunteers who helped deliver the hard copy newsletters and assisted with social events or helped out in other ways this past year.

Max Begley, your retiring Vice President refused to accept the proposition that a Speed Radar capable of working on water in the 5 knot range could not be made. The Radar was made, commissioned, and has proven operational. Well done Max. Recognising the value in reducing speed on the canals, the device was subsequently purchased by the City of Mandurah. Though deployed early 2019, your PMRA committee agreed to extend the CoM payment to this current financial year. Further examples have been developed and are now also operating along Australia's eastern seaboard.

To liaise and foster good working relations with government departments and other relevant bodies. To foster relations with media and inform the public.

PMRA members have, year on year, provided a mesmerising Christmas Light Display which draws tens of thousands of visitors to the Mandurah precinct stimulating and growing the number of tourist businesses. Your committee has also strongly pursued the need to improve safety during the Christmas Light season with reference to better directional signage, improved vessel lighting and reduced vessel speed. A further recommendation, in line with the BEN (Beach Emergency Number) scheme is to identify each individual canal should any emergency occur.

Late in July 2019 Max, Peter and myself met with Paddi Creevy and executive staff of the Peel Development Commission to discuss the mechanics and feasibility of installing a permanent Sand Bypass System at the mouth of the Peel Estuary. The cost of the plant and the complexity of acquiring the necessary permits etc. from the Department of Transport (DoT) has been a major setback. In spite of the PMRA enthusiasm for a permanent more efficient system, the last notice from Neil Carroll at the PMCWAG March 2020 meeting is that DoT have little appetite for the venture and choose to continue with the existing slurry, track design.

Online and printed newsletters organised and produced by Linda Thorpe, continue to inform PMRA members of local events and happenings.

Kerrie Andrews, an ex officio member is continuing as PMRA's Facebook page editor. Kerrie introduced several ideas, including a St. John's First Aid refresher course and spent many hours, co-editing with Peter Hick; the eagerly awaited PMRA book Port Mandurah 30 Years - Making a Community.

The Santa Afloat Committee with the team of lolly packers, Santas, skippers and elves again provided a seasonal pinnacle of a safe and fun attraction for the children and canines on the canals.

Ross Gibbs as your function coordinator bought several great ideas to the table highlighting in the extremely successful Hotham Valley Restaurant Train excursion.

The 2019 Christmas Party was again held at Mandurah Offshore Fishing & Sailing Club. The Port Mandurah 30 Years – Making a Community book was also launched at this event. It was a less formal dining event, was well attended by members and guests and from the majority of feedback a great success. A loud shout out Thank You to Santa extraordinaire - Geoff Campbell.

The Event

Skippers, Boats and Santas

Boxes of sweet packages were delivered to skippers on Christmas Eve and their boats, Santas and the crews invited by the skippers were on the water by 5.30pm displaying their PMRA banners and Christmas decorations, as well as broadcasting loud music.

Boat 1

Again Raymond Hind provided his boat and was skipper teaming up with Geoff Campbell as the perfect Santa. They did all of the Leeward side of the Old Marina; everything from the Southern Entrance and the cul-de-sacs to Leisure Way. This boat had 170 gift bags which was more than last year, with only a few left over.

Boat 2
